Savings noted in the budget will only amount to three quarters of the FY 2017-18 budget since the budget is not scheduled to be approved until September.

Director Morin states the Finance Committee has reviewed both budgets for FY 2017-18 and approve. He also informed other members that the budget would be more precise next year, currently, spending outweighs revenue.

2. Approval of the Mission Oaks Maintenance & Improvement District Budget for FY 2017-18.
