Director Ross met on May 23 with Recreation Committee Directors Ontiveros and Morin along with District Administrator Barton and Supervisor McAdam to discuss the philosophy for prioritizing recreation programs and services. What was discovered is that factors could change over time, it was decided to create a general philosophy; whatever is necessary for MORPD to eliminate or reduce programs or services the following factors will be considered:
 - Programs that are more recreation in nature will be viewed more favorably.

- Programs that serve youth and seniors may be viewed more favorably.
- Programs that are not offered elsewhere in the area may be viewed more favorably.
- Programs that have larger participation and social impact, and benefit the community, programs offered at MORPD facilities, and requiring least amount of human and financial resources that have the highest level of cost recover may be viewed more favorably.

Director Ross introduces Swanston Community Center intern Taylor Johnson, Pat Sieberg, Recreation Specialist and Terri McAdam, Recreation Supervisor. Terri McAdam supervises the Mission Oaks Community Center; she is one of three longest tenured employees being employed since 1983. Terri makes the community center very friendly and welcoming. People come from all over including Placer County and El Dorado Hills to attend dances. Terri coordinates 27 events throughout the year at MOCC, oversees 10 staff personnel, 15-20 contractors and 30 volunteers; she also has been supervising the Preschool program for the last six years.
